

SWFL SteamCon & Supernatural Summit Exhibitor Agreement Form

Event Information: SWFL SteamCon & Supernatural Summit is a 1 day event Combining Victorian-era fantasy with the unexplained, this event offers a unique journey from a Steampunk convention in the main ballroom to paranormal and UFO talks in the adjoining bar.

Show Date: Saturday, March 28, 2026 Vendor hall hours are 10am-6pm.

Space Description:

Table: 6'x5' total space, includes 2 seats, 2 badges. 6'x5' total space . Back displays are allowed, but no side displays. Back must be maximum 8' high and must be placed within the total selling space area of 6'wide x 5' deep (including table & chairs)

Booth: 10'x10' total space, includes 2 seats, 2 badges. Back & side displays allowed. Back Displays must be maximum 8' high and must be placed within the total selling space area of 10'x10' (including table & chairs)

If the "Bring Your Own Table Discount" was **not** selected, then the space will also include (1) 6' table.

Exhibitor set up

Vendor hall hours are Saturday 10am-6pm. All vendors should be set up by 9:45am. **Load in begins at 6:30am Saturday.** Please note there will **not** be Friday night load in options for this event, as the venue hosts nightly dances every Friday night. Artist/vendors who sell through their product may leave early, but will be required to leave business cards or promotional literature at each of their tables. Booth space should be cleaned prior to vendor/artist leaving; trash should not be left on the tables or floor. Please do not begin load out until after 5:45pm for the convenience and safety of our guests. Please let us know if you are planning to leave early so we can plan accordingly.

Badge Rules

All Staff working a table, a vendor's family or otherwise, are required to have a badge. Additional badges other than those included with a purchase of tables are \$10 each. Vendors should wear and keep their badges visible throughout the show to help distinguish them from guests. All "guests" of artist and vendors coming into the show, whether doing business or not; be they visiting family, customers who have pre-purchased and are picking up items, etc., must pay admission to be admitted into the show.

Theft / damage of Exhibitor Property

Vendor agrees to hold Nexus9LLC, SWFL SteamCon and the event venue not liable for any property loss, theft or damage that may occur before, after, or during the event. Each exhibitor is expected to appropriately display their materials and staff their tables in order to prohibit shoplifting or theft.

Artist and Vendor Rules and Guidelines

All materials must be original or licensed properly. Bootleg or copied materials may not be sold. Any materials rated Mature need to be out of reach from children, with no obscene graphics or nudity/partial nudity visible. Sword sales & prop weapon sales must be preapproved; gun sales are not allowed for this event, any other weapons would need to be preapproved. Vendor tables are non transferrable.

Artist and Vendors are required to follow general guidelines: no real weapons, no realistic toy guns; no bare feet, no skates, hover boards or skateboards inside the convention center unless it is preapproved, no play fighting unless it is part of a preapproved showing. No excessive foul language will be tolerated; ie screaming and cursing. Outside food and drinks **are** allowed in the venue but must be out of sight. To accommodate those with allergies & for liability & insurance purposes we ask that vendors do not burn candles or incense, or spray excessive perfume. Costumes must be family friendly. All vendors, guests, staff, ect are expected to greet & treat all attendees with respect & friendliness. Report any harassment immediately to convention security or event staff.

Facepainting

All facepainters must be **preapproved** & must use non allergenic facepaint. Facepainters assume full responsibility & liability for any harm due to allergic reactions,ect from use of product on consumers

Food & Beverage sales

Prepacked candy/chips & soda sales are allowed. Additional food sales must be preapproved. Some food trucks with applicable licensing will be pre approved to sell food for this event.

Violation of Event Rules

Nexus9 reserves the right to strictly enforce the event rules. Any artist or vendor who is determined to be in violation of these rules by Nexus9 will be, at Nexus9's discretion, removed from the show and may be barred from exhibiting at future Nexus9 events. Exhibitors instructed to leave must immediately vacate the host facility premises. Exhibitors refusing to comply will have their materials removed at their expense, and will bear all risk of damage associated with the movement of their materials. Any exhibitor creating a hostile situation with other vendors, guests, or event staff will also be removed under these same terms. No exhibitor who is removed from the show for any reason will be entitled to any refund of any fees, or any monetary damages.

Sales Tax

Vendors and artists are responsible for applicable sales tax on their products and reporting revenue.
